I. Main publication and its reviews.

The book *Philosophies of Polar Law*, ed. by Dawid Bunikowski and Alan D. Hemmings, was published by Routledge officially in 2021. This is the main publication of the sub-group. The following sub-group's members contributed to the book: Dawid Bunikowski (introduction and chapter 2), Giorgio Baruchello (chapter 4), Leena Heinämäki (chapter 6), Tom G. Svensson (chapter 7), Agnieszka Szpak (chapter 9), Elena Gladun (chapter 10). There were 10 chapters.

The book has got good reviews so far. IV. Other activities.

1. Professor Dawid Bunikowski became one of the **Editorial Board** members of “Journal of Environmental Law and Policy” (Canada). The journal was established last spring. The link to the journal is here: <https://www.grassrootsjournals.org/jelp/>.
2. Associate Professor Alexander Sautkin, a philosopher from Murmansk State Arctic University (Russia), was invited to be a member of the sub-group. Alexander organised ***The Ninth International Kant-Bakhtin scientific seminar*** on October 20th–21st this year. The event was held online. The seminar topic was “Human rights, legal constraints, redefined borders in the pandemic era”. Professor Dawid Bunikowski took part in the seminar with his paper.
3. There have been monthly **meetings (a. 6) on protection of sacred sites, organised by one of us Dr. Francis Joy** (University of Lapland) since last May. Francis is creating a kind of network of scholars interested in protection of indigenous sacred sites. Of the sub-group, Professor Patrick Dillon, Professor Dawid Bunikowski and Dr. Francis Joy are active members of this network.
4. Professor Elena Gladun and Professor Kamrul Hossain with their institutions participating in the **project entitled “Meet the Arctic: An interdisciplinary approach to learning Arctic societies, peoples and cultures (MeetArctic)”** received funding from the Team Finland Knowledge (TFK) programme under the Finnish National Agency for Education (Edu-Fi). It is 72,000 euros to implement a joint project between Finland and Russia. The consortium includes: the Arctic Centre of the University of Lapland, Tyumen State University, University of Oulu, and Yamal-Nenets Centre of Arctic Research. The project is coordinated by the Northern Institute for Environmental and Minority Law at the Arctic Centre of the University of Lapland, in cooperation with the UArctic Thematic Network on Arctic Law.
5. Professor Dawid Bunikowski became **Visiting Professor at Carleton** University, Department of Law and Legal Studies, Ottawa, Canada (25.10.2021-1.4.2022). His research project is about *Chosen current problems of legal philosophy in the context of so called “populism” and self-determination*. These self-determination considerations concern also the First Nations in Canada.
